9. The College / Institute must to submit an affidavit that the land/ buildings for the courses have been demarcated exclusively for the purpose of course (name & intake) under Aryabhatta Knowledge University, Patna within **thirty (30) days** from the date of issue of this letter.
10. This provisional affiliation will be subject to approval given by the State Government.
11. In the light of University notification vide letter no. 004/FIN/038/AKU/2014- 1323, dated 18/05/2020, the College/ Institute is directed to deposit the amount of Endowment fund in any nationalised / scheduled bank branch as Fixed Deposit (FD) in the name of college and thereafter the said FD will be pledge in favour of the Registrar, Aryabhatta Knowledge University.

Recommendation of the Inspection Team:-

A team constituted by Aryabhatta Knowledge University Patna vide Letter No 006/Affili/771/AKU/2024(Vol-II)-..... dt. 23-08-2025 visited St. Josephs Business College Budhhijeevi Colony, 70 Feet Road, PO- Saristabad, PS-Beur, Patna, Bihar-80002 to inspect the infrastructural and instructional facilities to inspect BCA and BBA courses with intake of **BCA (180 Seats)** and **BBA (60 Seats)** for the academic session 2025-26.

Observations & Findings:

During the Inspection team found sufficient infrastructural & Instructional facilities to continue BCA (180 Seats) and BBA (60 Seats).

Suggestions:

1. The institute should be asked to submit an affidavit declaring that the demarcated building is not being used for any other purpose.
2. Building for the courses to be affiliated with Aryabhatta Knowledge University, Patna should be demarcated with proper sign boards.
3. Facility of common room should be enhanced.
4. Computer labs should be upgraded in terms of more Computer UPS, LAN, Internet and recent software and hardware before commencement of the course. The computer lab has 70 computers having i3 configuration and 4GB RAM. The lab must have A.C facility so as to preserve computer for longer period.
5. The class room should have mention of the course for which they are being used.
6. Conference hall needs to enhanced with smart screen.
7. More classroom as per as norms of the university required to be ready before commencement of the course.
8. The existing library must be enriched with sufficient number of books for each course More books, Newspapers & AICTE prescribed journals/e-journals with DELNET facility before commencements of the course.

Recommendations:

On the basis of observations & findings and Letter of Approval (LoA) granted by AICTE, New Delhi vide letter no.: F.No. Northern /2025-26/1-45316651315 dated 31/07/2025 the Inspection team recommends to grant the provisional affiliation to St. Josephs Business College Budhhijeevi Colony, 70 Feet Road, PO- Saristabad, PS-Beur, Patna, Bihar-800002 courses for BCA with 180 intake capacity, and BBA with 60 intake capacity effective for the session 2025-26.
